INJUNCTION

The Mayor President of the Hon. Marbella Town Hall

MAKES IT KNOWN

As a continuation of the measures already adopted in Injunction of March 13, 2020, Ministry of Health and Families of the Regional Government of Andalusia, and having seen Royal Decree 463/2020 of March 14 published in the BOE (Official State Gazette) number 67 of March 14, the following **preventive measures** are taken:

The temporary closure of beaches, public and children's parks, bio-healthy facilities and calisthenics is agreed.

Citizen Attention.- (Entry Registry) The closure of the Citizen Attention Office and Entry Registry is agreed, promoting the telephone service (call centre: 952761100), the municipal website (www.marbella.es) and electronic administration (<https://sede.malaga.es/marbella/>) for any management with the City Council. Notwithstanding the foregoing, for urgent and unavoidable actions, minimum services are enabled.

The citizens of Marbella and professionals are informed that, in accordance with the third additional provision of Royal Decree 463/2020 of March 14, **the filing of administrative procedures is suspended and its deadlines stay interrupted**; these will be resumed at the time that the aforementioned Royal Decree or its extensions lose validity.

Collective public transport.- The use of urban transport will be restricted for essential movements and exclusively those authorised by Article 7 of Royal Decree 463/2020. The maximum capacity of the buses will be limited to 50% and efforts will be made to distance the driver from the first row of occupancy.

Taxis.- As for public transport services for passengers and travellers in cars at the municipality of Marbella (taxis), 50% of the vehicle fleet will work for specific days according to whether their licenses are even or odd, starting today Monday, March 16, 2020, working the taxis with licenses finished in even number.

They will also establish special cleaning, hygiene and disinfection measures, paying special attention to surfaces and objects of frequent contact.

All citizens are recommended to pay through credit cards or a telematic way, through mobile apps.

Limited Parking.- Payment and temporary limitations of the Limited Parking Zone (Blue Zone and Green Zone) are provisionally suspended.

Municipal Mobility Card.- The issuance of new Municipal Mobility Cards is suspended, and the municipal transport offices of the Arc of Marbella will remain closed.

In the security of having the understanding of the citizens of Marbella and visitors, it is appealed to the responsibility of all to avoid risk situations, comply with and follow the measures contained in Royal Decree 463/2020 of March 14, the orders of the Authority Officials, Law Enforcements of the different administrations, municipal officials as well as the indications and recommendations that are adopted at any time.

Any new measure and/or recommendations to be embraced will be adopted and informed through the appropriate Injunction and publication on the municipal website as well as in all municipal offices.
